2018 RULES

1. Register between 9:00-11:30 a.m. at the Information Tent on June 2. No registrations/changes after 11:30 a.m. No pre-registration will be taken.
 2. Contest is open to the first **10** registrants in each age group (Ages 12 & Under; Ages 13+) on a **first come, first served** basis. **NO EXCEPTIONS WILL BE MADE.**
 3. Contestants of all ages are welcome to participate. Parents/guardians of participants under age 18 must sign the release form below.
 4. The contest will be conducted in two heats with the one eating the most in each age group declared the winner.
 5. Fudge Rounds and water are provided.
 6. Both hands may be used.
 7. No “messy eating” or smashing of pies allowed. Pies must be eaten ONE AT A TIME.
 8. Partially eaten cakes will count. Measurements will be in halves.
 9. Cakes in the mouth at the end of the designated time period count, if swallowed.
 10. The person who eats the most cakes in 2 minutes (and keeps them down) wins.
 11. Contestants who regurgitate any food will be disqualified.
 12. The Fudge Rounds Eating Contest will be held at the stage area at Stuarts Draft Park at 1:00 p.m. as part of the Sweet Dreams Festival.
 13. Medals will be awarded to 1st place winners in each age category.
 14. All contestants should be at the stage area by 12:45 p.m. to begin lining up.
